Waiting after your COVID-19 vaccination	Ag fanacht tar éis do vacsaínithe COVID-19
What is changing?	Cad atá ag athrú?
Until now, people receiving the Moderna or Pfizer vaccines have been asked to wait for 15 minutes before leaving the vaccine centre in case of serious allergic reaction. This 15 minute wait has now been suspended for adults after 1st doses, 2nd doses and boosters.	Go dtí seo, iarradh ar dhaoine a fhaigheann na vacsaíní Moderna nó Pfizer fanacht 15 nóiméad sula bhfágfaidh siad ionad na vacsaíne i gcás imoibriú ailléirgeach tromchúiseach. Tá an fanacht 15 nóiméad seo curtha ar fionraíanois do dhaoine fásta tar éis 1ú dáileoga, 2ú dáileoga agus teanndáileoga.
Why is this changing?	Cén fáth go bhfuil sé seo ag athrú?
<ul style="list-style-type: none"> Because of the Omicron variant, the booster programme for adults is being speeded up. 	<ul style="list-style-type: none"> Mar gheall ar an leagan Omicron, tá an clár teanndáileog d'aosaigh á bhrostú.
<ul style="list-style-type: none"> We now have much more experience with giving these vaccines to millions of people and the rate of serious allergic reactions is very low (around 5-10 per million doses). People are not normally observed for 15 minutes after other vaccinations. 	<ul style="list-style-type: none"> Tá i bhfad níos mó taithí againn anois ar na vacsaíní seo a thabhairt do na milliún daoine agus tá ráta na bhfrithghníomhartha ailléirgeacha tromchúiseacha an-íseal (timpeall 5-10 in aghaidh an mhilliún dáileog). De ghnáth ní bhreadhnaítear ar dhaoine ar feadh 15 nóiméad tar éis vacsaínithe eile.

Who is advising this change?	Cé atá ag tabhairt comhairle faoin athrú seo?
The change has been advised by the four UK Chief Medical Officers, and has the support of the Medicines Healthcare products Regulatory Agency (MHRA) and the Joint Committee on Vaccination and Immunisation (JCVI). What should I do when I attend for vaccination?	Cad ba cheart dom a dhéanamh nuair a fhreastalaím ar vacsaíniú?
Please make sure you tell the vaccine centre if:	Cinntigh le do thoil go ndéarfaidh tú leis an ionad vacsaín:
<ul style="list-style-type: none"> you have a history of allergic reactions, particularly to other vaccines, or if you had an immediate reaction after a previous dose. (A family history of allergies is not a risk factor.) If so, you may be advised to stay for the 15 minutes; you have previously fainted following vaccination. 	<ul style="list-style-type: none"> má tá stair frithghníomhartha ailléirgeacha agat, go háirithe maidir le vacsaíní eile, nó má bhí imoibriú láithreach agat tar éis dáileog roimhe seo. (Ní fachtóir riosca é stair teaghlaigh ailléirgí.) Más ea, b'fhéidir go molfaí duit fanacht ar feadh na 15 nóiméad; tá tú tar éis lagú roimhe seo tar éis an vacsaínithe.
As with any vaccine, you must not drive for 15 minutes after the vaccine – this is because of the risk of fainting. If you do faint, stay flat on your back with your legs raised. If this doesn't make you feel better, then call for help. Otherwise, you will be able to leave the centre straight after your vaccine as long as you feel OK.	Mar aon le haon vacsaín, ní gá duit tiomáint ar feadh 15 nóiméad tar éis an vacsaín - tá sé seo mar gheall ar an mbaol go lagfaidh sé. Má lagaíonn tú, fan go cothrom ar do dhroim le do chosa ardaithe. Mura mbraitheann sé seo níos fearr ort, glaoighar chabhair ansin. Seachas sin, beidh tú in ann an t-ionad a fhágáil díreach tar éis do vacsaín a fhad agus a bhraitheann tú ceart go

What happens if I do get symptoms of an allergic reaction?	Cad a tharlóidh má fhaighim comharthaí imoibriú ailléirgeach?
Keep this flyer handy. You should look out for the following ‘ABC’ symptoms:	Coinnigh an bhileog seo áisiúil. Ba cheart duit faire amach do na hairíonna ‘AAC’ seo a leanas:

Consciousness	Comhfhiú
<ul style="list-style-type: none"> • feeling lightheaded or prolonged faint • clammy skin • confusion • unresponsive/unconscious 	<ul style="list-style-type: none"> • Meadhrán nó lag ar feadh tamall fada • Craiceann tais • mearbháll • neamhfhreagrach / neamhfhiúosach
These symptoms typically happen within 15 minutes of vaccination. If you experience any of these, call out for help and ring 999 immediately (or ask someone to do this for you).
